## APPLICATION INSTRUCTIONS

### MIXING

This product is supplied ready to use.

### SUBSTRATE PREPARATION

Before applying, wet the area in question with water. May be applied to dirty and damp surfaces.

### APPLICATION

Use the product neat. Mask up any adjacent surfaces to prevent damage. Protect plants and grass etc from overspray/run off. Brush or spray on the cleaner, working well into stain and leave for 15 - 20 minutes. After this time, use a hard bristle to remove the stain. Finally, wash down the area with water, preferably with a hose, before the product dries. Take care not to allow residues to run directly into fresh watercourses.

### LIMITATIONS

- Ensure container is always kept in a secure upright position during both storage and transit.
- Dispose of this product and packaging correctly. Do not allow to enter watercourses. Always read label before use and wear suitable protective equipment.
- Take care when working on interior surfaces and with artificial stone.
- Always test a small area before applying to the entire surface. On very sensitive surfaces, a 1:1 dilution as a trial is recommended, always add acid to water.
- Always wash the surface down after treatment.
- Protect plants and animals from contact with product.
- It is the user's responsibility to determine suitability for use. If in doubt, please contact Technical Services Department for further advice.
